### Emergency Medical Authorization

This release shall be binding upon any heirs, administrators, executors and assigns of mine. I further agree to indemnify the University from any loss liability, damage or cost it may incur due to my participation in said activity in any way whether caused by the UNIVERSITY or otherwise.

In the event of illness or injury resulting or arising directly or indirectly out of said activity, I hereby give my consent and authorization for (1) the administration of emergency first aid care and treatment at the scene of an emergency by faculty, staff members or volunteers of the UNIVERSITY or (2) the administration of any treatment deemed necessary by a licensed physician or dentist and (3) the transfer to any hospital reasonably accessible. This authorization is not intended to cover major surgery unless the medical opinions of two (2) licensed physicians and dentists, concurring in the necessity for such surgery, are obtained prior to the performance of such surgery.

I further declare and warrant that I am covered by sufficient medical and dental insurance and that such insurance will remain in effect during my child's participation in said activity.

## Camp Objective

The UNLV residential camp is designed to improve the skills of all players from ages 13-18. Players are divided based on age and ability to provide a challenging and competitive environment, while also having fun. The focus is to enhance the technical abilities through an increased amount of touches on the ball. Small sided games are used to develop tactical components and put the players in decision making situations. Full sided games are then added for the complete training environment. The player to staff ratio is kept low to maximize the experience and provide better instruction to each individual. Specialized instruction for goalkeepers will be provided by an experienced collegiate goalkeeper coach.
